3. Last 60 Days of Bank/Debit Card Activity – displaying their direct deposit.
4. A recurring installment bill (Power, Electric, Phone, Insurance)
5. LAST YEAR or TWO YEAR'S TAX RETURN AND REFUND AMOUNT - (Tax Preparer can provide)

With this information A+ Loans can underwrite your taxpayer and possibly approve a small consumer loan prior to their tax refund to assist your client. This also allows you to help your client prior to tax season to keep them using your tax service. You also can earn an additional \$20.00 for each approved loan referral.
